Terms & Conditions

This Sponsorship Agreement (hereinafter referred to as the “Agreement” or “Contract”) with Healthegy is effective upon receipt of the signed agreement and is applicable to the Ophthalmology Innovation Summit Events

1. Once the contract is signed, it is a binding agreement. After payment is received, there are to be no refunds following the execution of this agreement unless Healthegy cancels the event due to any unforeseen situations that would affect the general population from attending the summit. In the event of a cancellation, either a refund or credit letter will be issued. The credit letter must be utilized towards a future summit within a twelve-month period from the cancelled event.
2. There are to be no competing events held during the regular hours of operation of the summit. This includes scheduled set-up hours. Dinners or receptions should be held after hours. There are to be no side-tracks or outside sessions/presentations held in association with this event under the same roof without the prior consent of Healthegy.
3. If Sponsor is offered a speaking role, Speaker grants to Healthegy a non-exclusive license to use Speaker’s presentation and handout materials (collectively “Speaker Property”) in any manner associated with the summit deemed appropriate including, but not limited to, the reproduction, distribution, creation of derivative works, and display on the internet of Speaker Property. Healthegy maintains the right to use name, biographical information, photograph, audio, or video record presentation, including all materials prepared or provided by Speaker, for the purposes of keeping good records, to promote and publicize future summits, and to make archives available in all forms of media. Speaker also agrees to work directly with Healthegy and follow all deadlines to provide PowerPoint presentations and handouts that may be associated with and necessary for the summit.
4. A Sponsor Checklist Form will be sent by Healthegy upon receiving the signed contract. All items must be submitted in accordance with deadline notifications to ensure maximum benefits. A separate registration link and unique code will be provided for representatives using the complimentary registrations. All representatives must be registered upon receiving the link and code.
5. Upon signing of this agreement, you will be sent an electronic invoice.
